It is interesting that the Permanent Representative of Slovakia uses the same stamp like the Court.

It is necessary to add that the building of the Permanent Representative of Slovakia is 1.8 km from the building of the Court in Strasbourg.

But Human Rights Defense z.s. knows that for example the Permanent Representative of Belgium at the corner of the streets Robertsau and Schiller uses the different stamp than the Court.

But it is only one difference, that in the stamp at the Court was not color.


