1. NGO has declared to a problem of inadmissible decisions by the Czech Section of the European Court of Human Rights in Strasbourg follows:
2. NGO is requesting to examine the responsibility of a person who sent this letters to applicants.
3. NGO is requesting a new trial, retrial or re-open of these concrete cases before the European Court of Human Rights and the Council of Europe, because after the examination will new facts of a proceedings. It means for example a violation of a competent person at the Court, or a violation of an

international judge or a problem of any manipulation with documents of files at the Court or a manipulation with mails, blocking of mails and falsifications of letters in the name of the Court probably by the Czech Section at the Court or any others proofs.

4. In the previous correspondence of NGO is definitely that by suspected letters in the name of the Court is violated the Convention and human rights.

5. NGO will make public all files of cases which was declared as inadmissible.

6. NGO states that a publishing of the final decision in the database of the Court without all documents of files is cyberbully.

7. NGO states that in the situation of the right of public hearing, the citizen has a right to make public all files and not only any suspicious decision in the name of the Court.

8. NGO states that citizens have a rights to control the work of the Court.

9. If will publishing the all files of the case, it will be evident the root of the violation of the Convention.

10. NGO is requesting unilateral financial declaration in favor of a damaged citizen, a change of legal system and restitutio in integrum.

11. If the Court will not make consensually above meant, NGO will proceed against this violations by all legal means, for example publishing on Internet and submitting to the other international institutions for examination.

12. NGO will help for an achieving justice to Czech and Slovak damaged citizens in all dignity for a damaged citizens.
