### **Record of membership meeting of NGO**

**of 15 August 2019**

#### **NGO has declared**

1. The membership meeting of NGO analyses the case FALSE ACCUSATION (Křivé obvinění) <https://www.hrd-ngo.com/krive-obvini2/>.
2. NGO within its main goal – defense of human rights - puts on correct to inform the European Court of Human Rights in Strasbourg about the factual situation of human rights in the Czech republic.
3. The policeman Mr. Marian Rochl from the Regional Headquarters of Police in Hradec Králové states the server of NGO [www.hrd-ngo.com](http://www.hrd-ngo.com) as the result of of mental disorder, intoxication and addictive substances, because the server proceeds on the international conventions of protection of human rights.


4. Therefore the policeman Mr. Marian Rochl from the Regional Headquarters of Police in Hradec Králové requests the Head of NGO to investigate as mentally ill and to place her in a psychiatric hospital because, according to Mr. Marian Rochl every human rights defender is dangerous for society.

5. On the ground of these proofs, is a serious suspicion, that Mr. Marian Rochl would declare the server of the European Court of Human Rights <https://www.echr.coe.int/Pages/home.aspx?p=home> on the ground equality rule as the result of mental disorder, intoxication and addictive substances.

6. On the ground of these proofs, is serious suspicion, that Mr. Marian Rochl would request to the President of the European Court of Human Rights Mr. Linos-Alexandre Sicilianos – Greece, to investigate as mentally ill and place him in a psychiatric hospital because, according to Mr. Marian Rochl every human rights defender, including of the President of the international court, is dangerous for society.

7. The membership meeting has decided under the statutes of NGO to inform the European Court of Human Rights in Strasbourg and the President of Court Mr. Linos-Alexandre Sicilianos – Greece, about the situation of human rights in the Czech republic.
